

## END-USER LICENSE AGREEMENT

**IMPORTANT LEGAL NOTICE - READ CAREFULLY:** The Thin Desktop® software (hereinafter the “Software”) and related end-user documentation included herewith are licensed, not sold, subject to the terms of this End-User License Agreement (the “License Agreement”). Before you may install and use the Software and documentation, you must agree to be bound by the terms of this License Agreement. If you do not agree to the terms of this License Agreement, do not install, access, or use the Software or documentation.

This License Agreement is a legally enforceable contract between you (an individual or a single entity) and ThinLaunch Software, LLC (hereinafter “ThinLaunch”). The Software is protected by intellectual property laws and treaties. The Software is licensed, not sold. Any purchase of the Software or purchase of a Copy of the software mentioned in this License Agreement refers to a purchase of a license to use, download, install, copy, or distribute the Software or a Copy of the Software pursuant to the terms of this License Agreement. A Copy of the Software is any copy of the object code of the Software that is downloaded, installed, copied, or distributed to a computer, work station, or a computer-readable medium. For purposes of determining the quantity of Copies of the Software for which a license must be obtained from ThinLaunch, such quantity includes the number of computers or work stations to or on which the Software is or has been used, downloaded, installed, copied, or distributed.

### 1. AGREEMENT TO THIS LICENSE AGREEMENT

(a) This License Agreement applies to the Software and any accompanying distributable files, data and materials. You should carefully read the following terms and conditions before using, downloading, installing, copying, or distributing the Software. Unless otherwise agreed in a writing signed by an authorized representative of ThinLaunch, your use, downloading, installation, copying, or distribution of the Software indicates your acceptance of this License Agreement. You understand and agree that the terms and conditions of this License Agreement are the only terms and conditions applicable to your use of a Trial License or your purchase and use of a Full License of the Software. You further understand and agree that any additional or different terms specified, referenced, and/or incorporated by any document provided by you or on your behalf are hereby rejected by ThinLaunch.

(b) Please read the terms of this License Agreement below. If you do not agree to all of the terms and conditions of this License Agreement, do not use, download, install, copy, or distribute the Software. The terms and conditions of this License Agreement describe the permitted use and end user(s) of each copy of the Software you purchase. Each Copy of the Software for which you purchase a license is hereinafter referred to as a “Licensed Copy.”

### 2. GRANT OF TRIAL LICENSE

(a) The Software may be initially licensed to you on a trial basis for thirty (30) days, starting on the day you first install the Software. Subject to the terms below, ThinLaunch grants to you a non-exclusive, non-transferable, and non-renewable Trial License. This Trial License expires thirty (30) days after you first install the Software on any computer or workstation. Upon expiration of the Trial License after the trial period, you may not use the Software without obtaining a Full License from ThinLaunch.

(b) **PRODUCT ACTIVATION.** To use this product, You may need to activate the product over the Internet or enter a license code obtained from ThinLaunch. You may need to re-activate the product in the event you significantly modify the hardware configuration of the device on which the product is installed. You agree not to override, bypass, or interfere with the proper functioning of the activation process or any other security feature, authorization, licensing, activation, or reactivation mechanism used in the product. Furthermore, this product may automatically transmit an electronic signature of program inputs via the Internet to licensing servers operated by ThinLaunch. This signature allows ThinLaunch to identify violations of the licensing terms of this product. In addition, ThinLaunch receives and stores certain information regarding each computer on which this product is installed. You agree to the transmission, storage, and use of this information by ThinLaunch for purposes of enforcement of this agreement. This product automatically connects and interacts via the Internet with servers operated by ThinLaunch to implement certain features, download data, and perform other operations required to implement product functionality. You agree to this network activity for the purposes of implementing product functionality

(c) If you have a Trial License, the Software may contain a feature that causes the Software to cease functioning after thirty (30) days. Any attempt to disable or circumvent this feature, constitutes unauthorized use of the Software in violation of this License Agreement. Use of the Software after the expiration of the 30-day trial period and attempts to use, download, install, copy, or distribute the Software, or otherwise obtain an additional Trial License, without acquiring a Full License from ThinLaunch is a breach of this License Agreement and a violation of U.S. and international copyright laws.

(d) Subject to the terms of this License Agreement, a Trial License entitles you, without making any payment to ThinLaunch, to:

i) Use, for evaluative purposes only, one (1) copy of the Software on one (1) computer or workstation, without charge, for a period of thirty (30) days after you first install the Software on any computer or workstation.

ii) Give exact copies of the Software personally and without charge of any kind to anyone for evaluation purposes only, subject to the terms of this License Agreement, using tangible media of any kind or via email (but not in a bulk mailing or through unsolicited bulk emails);

iii) Distribute exact copies of the Software for evaluative purposes only, subject to the terms of this License, if done exclusively by allowing downloads through the public Internet and without charge of any kind; and

iv) Make as many exact Copies of the Software as you wish, for purposes of distribution as described in (ii) and (iii) above.

(e) You agree that you will not (and will not authorize or permit any of your employees, agents or third parties to) disable or attempt to disable any feature of the Software, for the purpose of circumventing any of the terms of this License Agreement or the intellectual property laws of the United States or any other country.

(f) You are specifically prohibited from charging or requesting donations for any distributed Copies of the Software, however made, and from distributing such copies with other products of any kind, commercial, or other otherwise, without prior written permission from ThinLaunch. Also, you are specifically prohibited from charging or requesting donations for providing access

to any hyperlink or other method that allows an end user to create or electronically transfer copies of the Software.

(g) Within ten (10) days of expiration of the 30-day trial period for the Trial License granted hereunder, you shall delete from your computers, workstations, and networks all electronic copies of the Software, including all parts thereof.

### 3. GRANT OF FULL LICENSE

(a) Subject to the terms and conditions set forth in this License Agreement, and payment of applicable fees for all Licensed Copies of the Software, ThinLaunch grants to you a non-exclusive, non-transferable Full License to download, install, execute and use the machine-readable, object-code version of the Software, together with all end-user documentation provided therewith, solely for your personal or internal business purposes

(b) If you purchase multiple Full Licenses, you have the right to install or access a copy of the Software on multiple computers up to the number of Licensed Copies that you have acquired, as determined below. If you purchase a single-user Full License, you have the right to install and use a single copy of the Software on one computer or workstation for non-simultaneous use by one or more persons and install a second copy of the Software on another computer or workstation for the exclusive use of the person who is the primary user of the first Copy of the Software.

(c) You may not give, transfer, or sell Copies of the Software to your customer or customers, or any third party, in whole or in part, nor include Copies of the Software, in whole or in part, in or with products you sell.

(d) Each Licensed Copy may be accessed through a network, provided that you have purchased a Licensed Copy for each workstation that will use the Software through the network. For instance, if 8 different computers or workstations access the Software on the network, you must purchase 8 Licensed Copies of the Software, regardless of whether the 8 computers or workstations will access the Software at different times or concurrently.

(e) For purposes of obtaining a Full License:

(i) If you have paid for a single-user Full License, you or your organization are deemed to have a single Licensed Copy of the Software and are authorized to access all software features.

(ii) If you have paid for multiple Full Licenses, you or your organization are deemed to have acquired a number of Licensed Copies of the Software equal to the number of Copies you have purchased from ThinLaunch, and are authorized to access all software features.

(iii) You agree to the activation procedure in section 2 (b)

(f) You may not alter or modify the Software, nor permit anyone else to do so.

(g) If you have purchased multiple Full Licenses, you are responsible for duplicating and distributing the Software for use in accordance with the terms of this License Agreement and for monitoring the number of Copies of the Software installed and used by your organization.

Under multiple Full Licenses, you may install the Software only on computers operated by or on behalf of your organization. Subject to United States export restrictions referenced below, other applicable laws and regulations, including the laws of countries other than the United States of America, and the other limitations set forth in this License Agreement, you may install and access Licensed Copies of the Software on computers located anywhere in the world, subject to the activation procedure in Section 2 (b).

(h) All rights of any kind in the Software which are not expressly granted in this License Agreement are entirely and exclusively reserved to and by ThinLaunch. The Software is protected by the United States patent and copyright laws and other applicable national and international laws and treaties.

(i) You may use, download, install, copy, and distribute the Software only as expressly provided in this License Agreement. You may not rent, lease, loan, sublicense, modify, translate, reverse engineer, decompile, disassemble, or create derivative works based on the Software, in whole or in part, nor permit anyone else to do so. You may not make access to the Software available to others in connection with a service bureau, application service provider, or similar business, nor permit anyone else to do so. The Full License granted hereunder includes no rights in or to the source-code version of the Software.

#### 4. TERM

A Trial License expires after 30 days. A Trial License cannot be renewed or replaced by another Trial License. You are only entitled to one Trial License. A Full License will continue indefinitely, unless it is terminated as set forth below.

#### 5. PERMITTED USES OF SOFTWARE

You may use the Software only for your personal or internal business use. You may not rent, lease, lend or provide your Copy or Copies of the Software for use by others, including, without limitation, through a commercial hosting service, application service provider, service bureau, or time-sharing service.

#### 6. PERMITTED COPIES OF SOFTWARE/AUDITING

(a) You may copy the Software only as required to download, install, execute, and distribute or use the Software as set forth in Sections 2 and 3 of this License Agreement and for backup and recovery purposes. A Trial License allows you to install and use for evaluative purposes, for a maximum of thirty (30) days, the Software on a single computer at a time for each Copy of the Software you download. A Full License allows you to install and use Copies of the Software on multiple computers, or make available to multiple end users over a network of computers, up to the number of Licensed Copies that you have acquired. You may not use the same Copy of the Software on multiple computers or make the same Copy of the Software available over a network where it could be used at the same time by a number of end users exceeding the number of Licensed Copies that you have acquired.

(b) At any reasonable time, and without notice, ThinLaunch may conduct an on-site audit of your computers, workstations, and networks for the purpose of determining whether the number of Copies of the Software used, downloaded, or installed exceeds the number of Licensed

Copies that you have acquired. If it is determined that the number of end users who could use Copies of the Software at the same time, whether as a result of installation of the Software on multiple computers or availability of the Software over a network accessible to multiple users, exceeds the number of Licensed Copies you have acquired, your Full License to the Software is terminated and you must pay ThinLaunch Liquidated Damages. As used herein, "Liquidated Damages" means an amount not less than the sum of the cost to ThinLaunch of conducting the audit and four (4) times the total Purchase Price of the number of Copies of the software used or available for simultaneous use, whether by installation or downloading on multiple computers or workstations or availability to multiple end users over a network of computers or workstations, exceeding the number of Licensed Copies, wherein "Purchase Price" corresponds to the purchase price of the Software at the time you received a Full License or the purchase price of the Software at the time the audit was conducted, whichever is greater.

## 7. RESTRICTIONS

(a) You shall not (and shall not authorize or permit your employees, agents, or third parties to):

(i) Use or copy of the Software, or any part thereof, except as expressly authorized in this License Agreement;

(ii) Modify or prepare derivative works of the Software, or any part thereof;

(iii) Disclose, demonstrate, distribute, sell, lease, sublicense, lend, give, share, transfer, assign, or otherwise make all or any portion of the Software available to any natural person, corporation, or other entity, except as expressly authorized in this License Agreement;

(iv) Translate, disassemble, decompile, decode, reverse engineer, or cause or allow discovery of the source code of the Software, except as expressly permitted by applicable law;

(v) Remove, obscure, or alter the titles, copyright notices, trademarks, logos, trademark notices, or other proprietary or restricted rights notices affixed to or contained in the Software;

(vi) Make any claim or representation of ownership or deny or challenge any claim of ThinLaunch's or its licensors' ownership of the Software;

(vii) Use the Software in any manner that violates any international, federal, state, or local law, rule, regulation, or ordinance; or

(viii) Use the Software in a manner that violates the software licenses granted to you by other companies that have provided software for your computer. For example, the Software is designed to be used with the Microsoft® Windows® operating system, and so you may not use the Software in a manner inconsistent with the Microsoft® Windows® license agreement.

## 8. YOUR WARRANTIES AND ADDITIONAL OBLIGATIONS

(a) You warrant that all individuals having access to your Copy or Copies of the Software (that is, the Copy or Copies you obtain upon agreeing to this License Agreement or any other Copy you have made from that copy) will observe and perform all the terms and conditions of this License Agreement. You shall, at your own expense, promptly enforce the restrictions in this License Agreement against any person who gains access to your Copy or Copies of the Software with your permission or while in your employ and who violates such restrictions by instituting and diligently pursuing all legal and equitable remedies against him or her. You agree to immediately notify ThinLaunch in writing of any misuse, misappropriation, or unauthorized disclosure, display, or copying of the Software that may come to your attention. You agree to indemnify and hold harmless ThinLaunch from any and all losses and third-party claims arising out of or in connection with your use of the Software or breach of this License Agreement.

## 9. OWNERSHIP

(a) Title, including the ownership of all patent rights, copyrights, trade secret rights, trade mark rights, know-how rights, and all other intellectual property rights in and to the Software shall remain at all times with ThinLaunch and its Licensors.

(b) No right, title, or interest in or to the Software is transferred to you under this License Agreement, and you shall have no right, title, or interest in or to the Software, except that you shall have the right to use the Software subject to the terms and conditions set forth in this License Agreement.

## 10. DISCLAIMER OF WARRANTIES

(a) THE SOFTWARE IS PROVIDED "AS IS," WITHOUT WARRANTY OF ANY KIND. TO THE FULLEST EXTENT PERMITTED BY LAW, THINLAUNCH AND ITS LICENSORS HEREBY DISCLAIM ALL WARRANTIES AND REPRESENTATIONS OF ANY KIND WHATSOEVER, WHETHER WRITTEN, ORAL, EXPRESS, IMPLIED, STATUTORY, OR ARISING BY OPERATION OF LAW, COURSE OF DEALING, COURSE OF PERFORMANCE, OR USAGE OF TRADE, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, AND NON-INFRINGEMENT, IN RELATION TO THE SOFTWARE.

(b) NEITHER THINLAUNCH NOR ANY OF ITS AFFILIATES OR LICENSORS WARRANT, GUARANTEE, OR MAKE ANY REPRESENTATIONS REGARDING THE USE OF OR THE RESULTS OF THE USE OF, THE SOFTWARE. YOU ACKNOWLEDGE THAT GOOD DATA PROCESSING PROCEDURE DICTATES THAT ANY PROGRAM, INCLUDING THE SOFTWARE, MUST BE THOROUGHLY TESTED WITH NON-CRITICAL DATA BEFORE THERE IS ANY RELIANCE ON IT, AND THE ENTIRE RISK ARISING OUT OF THE USE OR PERFORMANCE OF COPIES OF THE SOFTWARE REMAINS WITH YOU. THIS DISCLAIMER OF WARRANTY CONSTITUTES AN ESSENTIAL PART OF THIS LICENSE AGREEMENT.

(c) Because some states of the United States and some countries do not allow the disclaimer or limitation of certain warranties, the above disclaimer may not apply to you.

## 11. LIMITATIONS ON LIABILITY

(a) UNDER NO CIRCUMSTANCES SHALL THINLAUNCH, ITS LICENSORS, OR ANY OF THEIR RESPECTIVE DIRECTORS, OFFICERS, PRINCIPALS, SHAREHOLDERS, EMPLOYEES, AGENTS, AFFILIATES, CONTRACTORS, SUPPLIERS, SUBSIDIARIES, OR PARENT ORGANIZATIONS BE LIABLE TO YOU OR ANY THIRD PARTY FOR ANY DIRECT, INDIRECT, INCIDENTAL, SPECIAL, EXEMPLARY, CONSEQUENTIAL, OR PUNITIVE LOSSES OR DAMAGES (INCLUDING, WITHOUT LIMITATION, LOSS OF REVENUES, SAVINGS, OR GOODWILL, BUSINESS INTERRUPTION, AND LOSS OF, DAMAGE TO, OR DISCLOSURE OF DATA) ARISING OUT OF OR IN CONNECTION WITH THIS LICENSE AGREEMENT, INCLUDING, WITHOUT LIMITATION, ANY SUCH LOSSES OR DAMAGES ARISING OUT OF OR IN CONNECTION WITH THE SOFTWARE OR THE SERVICES RENDERED HEREUNDER OR YOUR USE OF OR INABILITY TO USE THE SOFTWARE.

## 13. TAXES

(a) You shall pay all taxes and duties, including all sales, use, excise, goods and services, and value-added taxes, and all related interest and penalties, that are levied, assessed, or

imposed by a governmental authority by reason of this License Agreement or any transaction hereunder, except (i) taxes for which you provide ThinLaunch a valid tax exemption or resale certificate; (ii) taxes based on ThinLaunch's net income; and (iii) interest and penalties caused by ThinLaunch, but not by you.

#### 14. TERMINATION

(a) You may terminate this License Agreement at any time. ThinLaunch may immediately terminate this License Agreement if you breach any representation, warranty, agreement, or obligation contained or referred to in this License Agreement. Upon termination, you must dispose of the Software and all Copies or versions of the Software by destroying the Software. Termination of this License Agreement does not entitle you to a refund. The provisions of paragraphs 2(c) and 7-17 of this License Agreement shall survive termination of this License Agreement.

#### 15. MISCELLANEOUS

(a) The Software, including, without limitation, the information included in its accompanying distributable files, data, and materials, any activation code and registration code file or information, and the know-how embodied in the Software, is confidential and trade secret information (the "Proprietary Information") that is proprietary to and solely owned or licensed by ThinLaunch, together with all related copyrights and trademarks relating thereto. You agree to maintain the Proprietary Information in strictest confidence for the benefit of ThinLaunch and its licensors. You shall not sell, license, publish, display, distribute, disclose, or otherwise make available or allow to be made available the Proprietary Information, including, without limitation, any activation codes, registration codes, or registration files, to any third party, nor use such Proprietary Information except as authorized by this License Agreement. The obligation under this paragraph shall survive any termination or cancellation of your licensing of the Software.

(b) No amendment to this License Agreement shall be binding unless made in writing and signed by a duly authorized representative of the party against whom enforcement is sought.

(c) You shall not sell, assign, license, sub-license, or otherwise convey, in whole or in part, by operation of law or otherwise, to any third party this License Agreement or any rights granted or services provided hereunder, without the prior written consent of ThinLaunch.

(d) There are no third-party beneficiaries of any promises, obligations, or representations made by ThinLaunch herein.

(e) This License Agreement shall be governed under the laws of the State of Minnesota without regard to its conflicts of law provisions. All actions or proceedings arising out of or relating to this License Agreement, its validity, performance, enforcement, or breach, or the subject matter of this License Agreement shall be venued exclusively in state or federal court in Minneapolis, Minnesota, and the parties hereby irrevocably consent and submit themselves to the personal jurisdiction of said courts for all such purposes. The United Nations Convention on Contracts for International Sale of Goods shall not apply to this License Agreement.

(f) If any litigation is brought to enforce this License Agreement, or arises out of this License Agreement, the prevailing party shall be awarded its reasonable attorneys' fees together with expenses and costs incurred in such litigation.

(g) The failure of either party at any time to require performance of any provision of this License Agreement or to exercise any right provided for herein shall not be deemed a waiver of such provision or such right. All waivers must be in writing. Unless the written waiver contains an express statement to the contrary, no waiver by either party of any breach of any provision of this License Agreement or of any right provided for herein shall be construed as a waiver of any continuing or succeeding breach of such provision, a waiver of the provision itself, or a waiver of any right under this License Agreement.

(h) If any provision of this License Agreement is held by a court of competent jurisdiction to be contrary to law, such provision shall be changed and interpreted so as to best accomplish the objectives of the original provision to the fullest extent allowed by law and the remaining provisions of this License Agreement shall remain in full force and effect.

(i) This License Agreement contains the entire understanding and agreement between the parties with respect to the subject matter hereof and supersedes all previous communications, negotiations and agreements, whether oral or written, between the parties with respect to such subject matter. Notwithstanding any inconsistent or additional terms and conditions that may be contained in a purchase order, voucher, or other similar document issued by you, such document shall be conclusively deemed to have been issued for your internal purposes only and the terms and conditions of this License Agreement shall prevail.

## 16. U.S. GOVERNMENT END USERS

(a) The Software is a "commercial item" as that term is defined in 48 CFR 2.101. Consistent with 48 CFR 12.212 and 48 CFR 227.7202-1 through 227.7202.4, all U.S. Government end users who or that acquire the Software do so with only those rights set forth in this License Agreement.

## 17. EXPORT RESTRICTIONS

(a) The Software is subject to certain export restrictions of the United States Government.
