Software License Agreement for Verdiem Surveyor 5.0

1. Introduction and Acceptance. This Software License Agreement is a legal agreement between you (either an individual or an entity) and Verdiem Corporation regarding the use of the Verdiem software that accompanies this Agreement ("**Software**"). BEFORE YOU CHECK THE BOX MARKED "I ACCEPT THE TERMS IN THE LICENSE AGREEMENT" BELOW, CAREFULLY READ THE TERMS OF THIS AGREEMENT. BY CHECKING THE BOX MARKED "I ACCEPT THE TERMS IN THE LICENSE AGREEMENT," YOU ARE AGREEING TO BE BOUND BY, AND ARE BECOMING A PARTY TO, THIS AGREEMENT. IF YOU DO NOT AGREE TO THE TERMS OF THIS AGREEMENT, CHECK THE BOX MARKED "I DO NOT ACCEPT THE TERMS IN THE LICENSE AGREEMENT" BELOW, AND THE SOFTWARE WILL NOT BE DOWNLOADED OR INSTALLED ON YOUR COMPUTER. IF YOU DOWNLOAD BUT DO NOT INSTALL THE SOFTWARE, PLEASE DESTROY OR DELETE ALL COPIES IN YOUR POSSESSION.

2. Grant of License.

(a) **Software.** Subject to the restrictions set forth in this Agreement, Verdiem hereby grants to you a non-exclusive copyright license to install and use the number of copies of the Software (in object code format and without modification) for which you have obtained an authorized License Key from Verdiem (see Section 3 for information about License Keys). The Software is "in use" on a computer or other device when it is loaded into the temporary memory (i.e., RAM) or installed into the permanent memory (e.g., hard disk, CD-ROM, or other storage device) of that computer or device.

(b) **Documentation.** Subject to the restrictions set forth in this Agreement, Verdiem hereby grants to you a non-exclusive copyright license to reproduce and use any printed, electronic, or other documentation provided with the Software ("**Documentation**") solely to support your authorized use of the Software.

3. License Key Feature. To use the Software, you must obtain a License Key from Verdiem (please see Section 21 for contact information). Your purchase of a License Key from Verdiem may be subject to terms and conditions in addition to those in this Agreement. The License Key feature will limit your use of the Software to the number of servers and clients for which you are licensed (and other limitations specified by Verdiem). The License Key feature will also automatically disable the Software if you use the Software longer than the term of, or beyond the scope of, your license to use the Software. You acknowledge that upon the expiration of your license to use the Software, and if Verdiem has not issued you a new License Key, the Software may cease to function in some or all respects, and you may lose access to data made with or stored using the Software. You acknowledge that the disabling of the Software is a critical feature of the license rights and responsibilities conveyed under this Agreement. You must not disable, attempt to disable, or help a third party to disable the License Key feature of the Software.

4. Special Provisions Regarding Third Party Software. The Software may contain or be distributed with third party software that is covered by a different license terms ("**Third Party Software**"). Information concerning the inclusion of Third Party Software, if any, and the notices, license terms, and disclaimers applicable to that Third Party Software are contained in one or more licenses.txt files provided with the Software (the server and client portions of the Software include separate licenses.txt files). This Agreement does not apply to any Third Party Software identified in a licenses.txt file provided with the Software.

5. No Transfer, Modification, or Reproduction. You may not rent, lease, sell, assign, loan, or otherwise transfer the Software. You may not transfer or assign the rights and obligations set forth in this Agreement without Verdiem's written consent. You may not remove or destroy any copyright notices or other proprietary markings. You may not modify or adapt the Software, merge the Software into another program, or create derivative works based on the Software. You may not distribute the Software without Verdiem's authorization.

6. Ownership. The licenses granted to you in Section 2 are not a transfer or sale of Verdiem's ownership rights in or to the Software. Except for the licenses granted in Section 2, Verdiem retains all right, title and interest (including all intellectual property rights) in and to the Software. The Software is protected by applicable intellectual property laws, including United States copyright laws and international treaties.

7. No Technical Support. Unless you separately purchase support services from Verdiem (please see Section 21 for contact information), Verdiem is not obligated to correct errors or provide any technical support related to use of the Software.

8. Automated Features. The Verdiem Software contains a feature that automatically collects information relating to the Verdiem Software and the computers on which the Verdiem Software operates or with which it interacts, such as a computer's power settings and the types of devices that are attached to a computer. This information is owned by Verdiem and Licensee hereby irrevocably assigns to Verdiem all right, title, and interest in and to this information. This information may be transmitted to Verdiem by you or by the Verdiem Software automatically.

9. Feedback. If you provide any feedback to Verdiem concerning the functionality and performance of the Software (including identifying potential errors and improvements) ("**Feedback**"), you hereby assign to Verdiem all right, title, and interest in and to the Feedback, and Verdiem is free to use the Feedback without any payment or restriction.

10. No Reverse Engineering. In order to protect the trade secrets and proprietary know-how contained in Software, you will not decompile, disassemble, or reverse engineer the Software except as expressly permitted by applicable law.

11. Reference. Unless otherwise agreed by you and Verdiem when you obtain a License Key, Verdiem may publish a press release announcing that you have licensed the Verdiem Software and the general context of the intended use; and allow the name and logo of your entity to be posted on Verdiem's web site and in marketing and advertising materials.

12. Termination. Unless otherwise agreed by you and Verdiem when you obtain a License Key, this Agreement will be effective upon installation of the Software and will terminate upon the earlier of: (a) your failure to comply with any term of this Agreement; (b) return, destruction, or deletion of all copies of the Software; or (c) upon Verdiem's notice to you. Verdiem's rights and your obligations will survive the termination of this Agreement. Upon termination of this Agreement, if requested by Verdiem, you will certify in writing to Verdiem that all copies of the Software have been destroyed or deleted from any and all computer libraries or storage devices.

13. Limited Software Warranty. If you are using an "alpha", "beta", or other pre-commercial release version of the Software, the Software is provided "AS IS" and without any warranties. Verdiem warrants that commercially released versions of the Software will perform substantially in accordance with the Documentation for a period of 60 days after receipt by you. Verdiem's entire liability and your exclusive remedy for breach of this warranty will be, at Verdiem's option, either (a) refund of the license

fee paid by you; or (b) repair or replacement of the Software that does not meet this warranty and that is returned to Verdiem. This limited warranty will be void if failure of the Software has resulted from any accident, abuse, misuse, or misapplication by you. Replacement Software will be warranted for the remainder of the original warranty period or 30 days, whichever is longer.

14. NO OTHER WARRANTIES. EXCEPT AS SET FORTH IN SECTION 13, THE SOFTWARE IS PROVIDED ON AN "AS IS" BASIS. YOU ASSUME ALL RESPONSIBILITIES FOR SELECTION OF THE SOFTWARE TO ACHIEVE YOUR INTENDED RESULTS, AND FOR THE INSTALLATION OF, USE OF, AND RESULTS OBTAINED FROM THE SOFTWARE. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, VERDIEM DISCLAIMS ALL WARRANTIES, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY, QUALITY, ACCURACY, TITLE, NON-INFRINGEMENT, AND FITNESS FOR A PARTICULAR PURPOSE WITH RESPECT TO THE SOFTWARE AND THE DOCUMENTATION. THERE IS NO WARRANTY AGAINST INTERFERENCE WITH THE ENJOYMENT OF THE SOFTWARE OR AGAINST INFRINGEMENT. THERE IS NO WARRANTY THAT THE SOFTWARE OR VERDIEM' EFFORTS WILL FULFILL ANY OF YOUR PARTICULAR PURPOSES OR NEEDS, INCLUDING THOSE OF ANY END USERS OF APPLICATIONS DEVELOPED BY YOU.

15. LIMITATION OF LIABILITY. UNDER NO CIRCUMSTANCES WILL VERDIEM BE LIABLE FOR ANY CONSEQUENTIAL, SPECIAL, INDIRECT, INCIDENTAL OR PUNITIVE DAMAGES WHATSOEVER (INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF BUSINESS PROFITS, BUSINESS INTERRUPTION, LOSS OF BUSINESS INFORMATION, LOSS OF DATA OR OTHER SUCH PECUNIARY LOSS) ARISING OUT OF THE USE OR INABILITY TO USE THE SOFTWARE, EVEN IF VERDIEM HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. THE FOREGOING LIMITATIONS ARE INDEPENDENT OF THE EXCLUSIVE REMEDY PROVIDED IN SECTION 13 AND WILL APPLY NOTWITHSTANDING ANY FAILURE OF SUCH EXCLUSIVE REMEDY. IN NO EVENT WILL VERDIEM'S AGGREGATE LIABILITY FOR DAMAGES ARISING OUT OF THIS AGREEMENT EXCEED THE AMOUNT PAID BY YOU FOR THE SOFTWARE OR RELATED LICENSE KEYS. THE FOREGOING EXCLUSIONS AND LIMITATIONS OF LIABILITY AND DAMAGES WILL NOT APPLY TO CONSEQUENTIAL DAMAGES FOR PERSONAL INJURY.

16. Liquidated Damages. Both parties agree that it would be difficult to ascertain the exact amount of damages that Verdiem would suffer if you breach the terms of this Agreement, especially the prohibition on use of the Software without a License Key. Therefore, the parties agree that, if you breach the terms of this Agreement, in addition to any other remedies available to Verdiem under this Agreement or by law, Verdiem will be entitled to recover from you, as its liquidated damages, the amount that Verdiem would have received for the appropriate License Key at Verdiem's highest published rates at the time it is determined that you have been in breach. The parties agree that this amount represents a reasonable estimate of the damage that Verdiem would suffer.

17. Audit. You must keep current, complete, and accurate records regarding your reproduction, installation, and use of Software. You will provide such information to Verdiem, so long as Verdiem does not make more than two requests during any 12-month period. You will, after reasonable prior notice from Verdiem, provide Verdiem with reasonable access to your premises, records, and personnel so that Verdiem may audit and confirm that you comply with this Agreement. If an audit reveals any reproduction, installation, or use of the Software that is not compliant with this Agreement, you will promptly comply with this Agreement and pay the additional fees (at Verdiem' then-current rates) due plus interest at the rate of 1.5% per month or the highest rate allowed by law, whichever is lower. You will also promptly reimburse Verdiem for its reasonable costs of conducting the audit if the audit reveals any noncompliance.

18. Indemnification. You will indemnify, hold harmless, and defend Verdiem (including all of its officers, employees, directors, subsidiaries, representatives, affiliates, and agents) and Verdiem's suppliers from and against any damages (including attorney's fees and expenses), claims, and lawsuits that arise or result from your use of the Software.

19. Export Restrictions. You may not export or re-export the Software without (a) the prior written consent of Verdiem and (b) complying with applicable export control laws and obtaining any necessary permits and licenses.

20. General. This Agreement is governed by the laws of the State of Washington, without reference to its conflict of laws principles. Any dispute between you and Verdiem regarding this Agreement will be subject to the exclusive jurisdiction of the state and federal courts located in King County, Washington in connection with any action arising under this Agreement. This Agreement is the entire agreement between you and Verdiem and supersedes any other communications with respect to the Software, except that this Agreement does not supersede any additional terms regarding the purchase and use of License Keys with the Software and this Agreement will be superseded by any agreement for the licensing of the Software that explicitly states that it supersedes this Agreement and is signed by Verdiem. If any provision of this Agreement is held invalid or unenforceable, the remainder of this Agreement will continue in full force and effect.
