### Carahsoft Listed on *Inc.* Magazine's 2011 List of Fastest Growing Companies for Fourth Consecutive Year

The 2011 [Inc.500/5000](#) rankings are based on percentage of revenue growth when comparing 2007 to 2010.

With 2010 revenue of \$834.5 million, Carahsoft was the second largest [government services company](#), as well as the second largest company among all those ranked from the [Washington DC metro area](#). Carahsoft's 264 percent growth rate ranked in at [#1126](#) on the list overall. The median growth rate of companies is 94 percent.

The Inc. 500/5000 list also highlighted the Top 100 Companies by gross [dollars of growth](#) and by [2010 revenue](#). Carahsoft was 9<sup>th</sup> by gross dollars of growth and Carahsoft ranked 29<sup>th</sup> by revenue.
