## Shipping

We ship via United Parcel Service, USPS and FedEX. We ship every day M-F (holidays excluded). Unless otherwise noted, your course materials will ship within two business days of receipt of your order and/or credit card approval. Orders requesting priority shipping must be received by 12:00 PM P.S.T. to ensure same day shipping. Orders requesting expedited shipping which are received after 12:00 PM P.S.T. will ship the next business day. All Course Materials will ship to you for free. This applies to "Standard Shipping" which will be FedEx, UPS or USPS Ground (30 days for delivery).

## Rescheduling
